WHAT IS ASBESTOS ?

Asbestos is a group of minerals that are resistant to heat and fire and do not conduct electricity. Because of these qualities, manufacturers began incorporating asbestos on a massive scale beginning in the late 1800's.

TYPES OF ASBESTOS DISEASE

MESOTHELIOMA

Every year thousands of workers are diagnosed with Mesothelioma. The only known cause of this deadly cancer is exposure to asbestos. Mesothelioma usually strikes in the lining of the lung (pleura) or the abdominal cavity (peritoneum). Even a brief exposure to asbestos dust can cause Mesothelioma. This latent disease can strike 20 to 30 years after the last exposure to asbestos has occurred. Unfortunately, asbestos dust brought home on a worker's clothing puts spouses and children of workers at risk.

ASBESTOS LUNG CANCER

Asbestos is a potent carcinogen which can cause all types of lung cancer. Like Mesothelioma, asbestos lung cancer can develop decades after the victim's last exposure to asbestos. Many workers who were exposed to asbestos also smoked cigarettes. This combination of smoking and asbestos exposure greatly increases the risk of contracting lung cancer. A worker exposed to asbestos who also smoked is still entitled to seek compensation for his asbestos related lung cancer.

ASBESTOSIS

Asbestosis is a non-malignant scarring in the lungs caused by breathing asbestos fibers. While for the most part invisible to the human eye, asbestos fibers are very hard and sharp and cause scar tissue to develop in the lungs. This scarred lung area is no longer able to do its job of providing oxygen to the body causing the victim to be short of breath. There is no cure for asbestosis and it can get progressively worse even after the exposure to asbestos has stopped. The health effects of asbestosis can range in severity from mild shortness of breath to total disability requiring the victim to be on oxygen 24/7.

OHIO'S ASBESTOS LEGACY

Ohio has been hit hard by the asbestos disease epidemic due our state's history of heavy industry and widespread use of asbestos containing products. Below are just a sampling of trades and jobsites effected by asbestos.

OTHER AREAS OF HEAVY EXPOSURE TO ASBESTOS



PLASTIC MOLDING

Asbestos fibers were added to plastic molding compounds well into the 1980's which has created a whole new generation of asbestos disease victims. Asbestos acted as a reinforcing and fireproofing agent in the finished molded products. Workers in plastic molding plants across Ohio were exposed to large amounts of asbestos dust with absolutely no warnings about the hazards they faced. Molded Products Containing Asbestos:

ASBESTOS EXPOSURE IN PLASTIC MOLDING PLANTS

Asbestos exposure occurred from the start of the plastic molding process and ended in the finishing department. Bags and barrels of asbestos containing molding compounds were opened in the preform department and dumped into hoppers causing large amounts of dust. Molded parts made their way to the finishing departments where they were hand-sanded by workers which exposed the finishers to large amounts of asbestos dust. Brooms and air hoses were often used to clean up dust and debris throughout the plant which added to the dust hazard. This asbestos dust hazard existed in plants that used injection molding processes as well as compression molding processes.



HOUSEHOLD EXPOSURE

Many victims of asbestos disease were not exposed in the workplace but rather in their own homes. These exposure include:

Exposure to asbestos brought home on a workers clothes which is then handled and washed by family members

- Exposure to asbestos during home remodeling (floor tiles / joint compound)
- Exposure to asbestos during automobile repairs (asbestos brakes / clutches)
- Exposure to materials used in hobbies such as ceramic work, pottery making or gardening



NAVY EXPOSURE

Many Navy veterans were heavily exposed to asbestos while serving our country which has led to high rates of mesothelioma among sailors especially those stationed below deck in the engine rooms. Exposures occurred at sea and also during overhauls while in dry-dock. We have helped many Navy Veterans suffering from asbestos related diseases recover compensation.



BODY TALCS AND POWDERS

Many body talcs and powders widely marketed and used across the country were contaminated with asbestos fibers. Millions of Americans unknowingly exposed themselves to asbestos dust on a daily basis while applying these body powders.

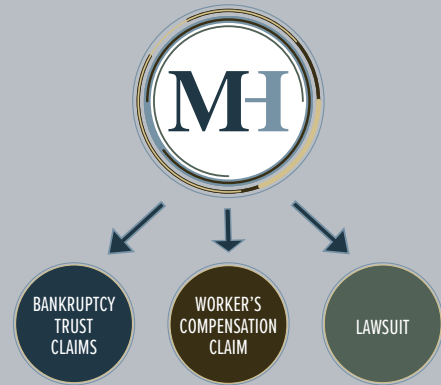

Ohio has what’s called a STATUTE OF LIMITATIONS which requires you to bring your claim within a certain time period. Generally, you have 2 years from the date you are told that you have an asbestos related injury and/or 2 years from the date of death from an asbestos injury in which to bring your claim. HOWEVER, there are exceptions to the general “2 year rule” so it is important to consult with an experienced asbestos attorney regarding the Statute of Limitations even if you think it may be too late to bring a claim.

1 BANKRUPTCY TRUST CLAIMS

Many of the major asbestos companies who are responsible for exposing Ohio workers to deadly asbestos dust have sought protection in Federal Bankruptcy Courts. As part of the bankruptcy process these companies have been required to set up Trusts to pay victims. The Trust process requires evidence of exposure as well as evidence of an asbestos injury. This is not an easy process but McDermott-Hickey has developed the knowledge and expertise in navigating the various Trust requirements to obtain compensation for our clients who were exposed to and injured by products covered under the Trust.

Bankruptcy Trust claims can be a good choice for clients who wish to receive compensation but do not want to go through all the requirements of a traditional lawsuit in court.

2 WORKER'S COMPENSATION CLAIM

If you are exposed to asbestos at work and develop an asbestos disease you may be entitled to bring a claim under Ohio's Worker's Compensation Laws. If successful, a Workers Compensation claim may pay for medical bills and also pay a

3 LAWSUIT

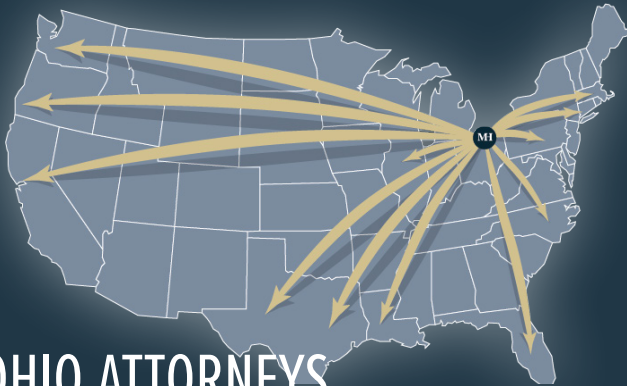
